Biographical Note

Dr. Mohammed Moniruzzaman Khan has been involved in academia and research in the areas of disaster, gender, environment, climate change, globalization, women empowerment, development of agency, consumption, social exclusion, indigenous community and other areas of social development and social sciences since late nineties. In 2022, he joined as Associate Professor at IDMVS. Prior to this, he joined as lecturer in the Department of Sociology in 2008 and got promoted as Assistant Professor, Associate Professor and Professor with and for excellence in academia and research in 2010, 20016 and 2020 consecutively in the same department. Dr. Mohammed Moniruzzaman Khan has over 20 years of experience in conducting research and consultancy work with national and international non-government organization in the areas of disaster, gender, environment, climate change, women empowerment, development of agency, minority, marginal group, indigenous community etc. After obtaining BSS and MSS in Sociology from the University of Dhaka Dr. Khan has achieved his 2nd Masters (Master of Science) Degree from London School of Economics and Political science (LSE), London, UK. Dr Khan's PhD from the University Canterbury, New Zealand on 'Disaster and Women: The Wave of Change in the Position and Status of Women in the Coastal Bangladesh' is one of the pioneering Ph.D research in the context of disaster prone coastal Bangladesh. In the Ph.D dissertation Dr Khan displayed his expertise of using multiple research tools and techniques via methodological triangulation to build nexus between and among various socio-cultural factors which has been highly appreciated by the reviewers and examiners. This unique piece of work further developed and enriched his research, academic and professional experience and knowledge which has been published on November, 2022 as book titled '*Disaster and Gender in Coastal Bangladesh: Transformation of Women's Roles in Reducing Disaster Risk and Vulnerability*' from Springer Nature: Singapore. In this book Dr. Khan focuses discourse of disaster and women in the existing socio-cultural settings and state of disaster related affairs in coastal Bangladesh. Focusing on women's experiences of

coastal Bangladesh during disaster-related time periods being confined with gender-related identity for institutional local practices, unequal distribution, and lack of access/entitlements to resources, role of GOs and NGOs etc. this book unearthed various issues ranging from disproportionate vulnerability, coping and adaptation mechanisms for women, limitations for promoting participation and involvement of women in the decision making process both in family and society. Also a very recent (2023) book of Dr. Khan titled '*Coastal Disaster Risk Management in Bangladesh: Vulnerability and Resilience*' published from Routledge: London addresses disaster and disaster risk reduction (DRR) practices, constraints and capacity in the context of coastal Bangladesh. The in-depth study via methodological triangulation not only in these two books rather in different research project, evaluation of the projects, assessment of the project and consultancy with government and non-government organization for last more than 20 years made Mr Khan very efficient and flawless in social research.

Research Interest:

Vulnerabilities to disaster are not equally distributed all over the world because of variations in economy, culture, development processes, settlement processes, politics, resource management etc. which is certainly putting an increasing group of people at higher risk than others. Experience of environmental hazards and risks of catastrophic disaster are shaped by elements of social structures including class, religion, age, physical ability and gender. Different social groups and different individuals carry disproportionate 'vulnerability bundles'. For example, women are the most at risk when hazardous conditions unfold in disastrous events such as cyclones. And gender in this regard is a pervasive division taking access to social and economic resources away from women.

- How do disaster, women and vulnerability function in disastrous times in the coastal area in Bangladesh?
- What are the local practices that are causing disproportionate vulnerability for women?

These are two of many research questions that disaster researcher Dr. Mohammed Moniruzzaman Khan, Associate Professor has focused on in his research work 'disaster and gender' in the rural area in Bangladesh. Disaster has obvious and devastating effects on the people whose everyday lives they touch. But what is the nature of impact and how does it differ for men and women? These questions led Dr Khan to explore in-depth on some other question such as:

- Is only gender matter or something else make the women disproportionately vulnerable?
- How do unequal access and entitlements to resources impact women in vulnerable situations?
- How does involvement and participation of women/women reduce vulnerability, develop agency and empower women?

- How are GO and NGOs interventions contributing in reducing vulnerability and mainstreaming women with decision making process?
- Are there any changes in local practices, cultural context, lifestyle, livelihood options, participation with decision making process for women in facing disaster?

Taking teaching and research as career with an expertise on ‘disaster, gender and environment’ Dr. Khan’s one and only mission and vision is to ‘empower and develop agency of women’ in DRR institutionally through sustainable development in the most disaster-prone coastal area and for most vulnerable people which will ultimately assist the government to achieve SDG.
