- 6. Quotation in a sealed envelope or by fax or through electronic mail shall be submitted to the office of the undersigned on or before 26/07/2023, 02.00 PM. The envelope containing the Quotation must be clearly marked "Quotation for \( \). Supply, Installation, Testing & Commissioning of a new Desktop Computer instead of old & faulty Desktop Computer for Audio Recording System at Senate Bhabon Auditorium 1+450 capacity Digital Conference system, University of Dhaka. and DO NOT OPEN before 26/07/2023, 02.30 PM Quotations received later than the time specified herein shall not be accepted.
- 7 The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.
  - All Quotations must be valid for a period of at least 120 days from the closing date of the Quotation.
- 8. No public opening of Quotations received by the closing date shall be held.
- 9 Quotationer's rates or prices shall be inclusive of profit and overhead and, all kinds of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law, if the Contract is awarded.
- 10. Rates shall be quoted and, subsequent payments under this Contract shall be made in Taka currency. The price offered by the Quotationer, if accepted shall remain fixed for the duration of the Contract.
- 11. Quotationer shall have legal capacity to enter into Contract. Quotation, in support of its qualification shall be required to submit certified photocopies of latest documents related to valid Trade License, Tax Identification Number (TIN) with in income Tex Certificate, VAT Registration Number, National ID Card and Financial Solvency Certificate from any scheduled Bank; without which the Quotation may be considered non-responsive.
- 12. Quotations shall be evaluated based on information and documents submitted with the Quotations, by the Evaluation Committee and, at least three (3) responsive Quotations will be required to determine the lowest evaluated responsive Quotations for award of the Contract.
- 13. In case of anomalies between unit rates or prices and the total amount quoted, the unit rates or prices shall prevail. In case of discrepancy between words and figures the former will govern. Quotation shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.



- 14. The supply of Goods and related services shall be completed within 10 days from the date of issuing the Purchase Order.
- 15. The Purchase Order that constitutes the Contract binding upon the Supplier and the Procuring Entity shall be issued within 14 days of receipt of approval from the Approving Authority.
- 16. The Procuring Entity reserves the right to reject all the Quotations or annul the procurement proceedings.
