

Research proposals in English must be structured as follows: (I) The Title; (II) Abstract/Executive Summary; (III) Introduction; (IV) Problem Statement; (V) Research Rationale; (VI) Research Question(s) and Objective(s); (VII) Research Scope; (VIII) Literature Review; (IX) Research Methodology; (X) Chapter outline; (XI) Timeline; (XII) Detailed Budget (including cost break-up); (XIII) Conclusion; (XIV) References. The proposed timeline and budget are required to match the permissible limits detailed below.</p> <p>B. Research proposals must be accompanied with a cover letter addressed to the official inviting this EOI (Please see the row in the bottom). A separate title page and curriculum vitae (CV) of the author(s) must be attached with the research proposal.</p> <p>C. Proposed research should be in the fields mentioned below.</p> <p>D. Research proposals must not exceed 2500 words, excluding references. The author must provide word count in the title page or in the cover letter (Standard Application Form).</p> <p>E. Incomplete research proposals will not be considered. Research proposals will be reviewed, selected and funded in accordance with the provisions of the Research Policy of BCSAA.</p> <p>F. The shortlisted research proposals are required to be presented by the researcher(s) before final selection.</p> <p>G. The BCSAA authority reserves the right to reject any research proposal without assigning any reason whatsoever.</p>
Permissible Budget and Time Limit	Only one type of original research will be considered for funding under the relevant provisions of the Research Policy of BCSAA. 1. C-type Research: Up to 10,00000.00 (Ten Lac) [Not more than 12 Months]
Submission of Research Proposal	Complete research proposals in Hard Copies must be submitted to the office inviting this EOI on or before 15.01.2025 (within office time – 5pm). Research proposals submitted after this deadline shall not be considered.
