



# Call for Book Chapters

## 1. Preparing your Manuscript

Manuscripts submitted to Essays on Gender and Development Studies, Vol. 1 have to be original, coherent with the themes, and they should neither be published (even partially) previously nor be under review for publication in another journal/volume in any language.

Manuscripts can be of two types: Original research work-based and review-based articles. However, the volume prefers to select original research-based articles rather than comprehensive analysis-based review articles.

Manuscripts should not be more than 7500 words including everything. Manuscripts must contain a title, abstract, introduction, background, theory/concept, methods, result, discussion, and conclusion. The word limits include abstract, keywords (should contain between 3 and 5 keywords), table, figure, footnote, acknowledgment, and endnote.

- b) Care economy
- c) Gender and work
- d) Gender and climate change
- e) Gender-based violence
- f) Gender and digital inclusion
- g) Gender and reproductive health

- l) Gender and Sports
- m) Gender and disability
- n) Gender and minority group
- o) Gender and Sustainable Development

## 2. Formatting and template

Author/s can submit their manuscripts in Word format.



### **3. Cover letter**

Author/s should submit a cover letter with each manuscript submission. Authors should mention their full names, affiliations, and further details about the identifying text removed from the manuscript. They should also explain why the contents of manuscripts are significant and why their papers fit in the journals. Most significantly, authors should confirm manuscripts are original, unpublished, and unsubmitted research work.

### **4. Back matters**

Author contributions: Author/s should mention individual contributions per section. In the cases of more than one author, please specify their individual contribution. The following statement should be used: conceptualization- A.A. and B.B.; Methodology- C.C. and D.D.; Data Collection- E.E. and F.F., Analysis- G.G. and H.H.; First draft- I.I. and J.J.; Editing- K. K. and L.L. Besides, the author/s also need to mention all authors have a common opinion regarding their publication.

Funding: Authors should disclose all sources of funding for their research paper.

Institutional Review Board Statement: Author/s should submit their institutional review board statement or certificate and approval number if their research requires.

Informed consent statement: Authors should provide detailed information about informed consent statements if their study involves humans.

Conflict of interest: Author/s must declare no conflict of interest.
